**AFFIDAVIT FOR WARRANT OF ARREST AND DETENTION**

The undersigned Affiant, who after being duly sworn by me, on oath, makes the following statement:

I have good reason to believe and do believe that:

On the 24<sup>th</sup> day of **December, 2021** in Travis County, Texas –did there and then knowingly or intentionally commit the offense of:

**RESISTING ARREST  
CLASS A MISDEMEANOR  
Texas Penal Code Section 38.03(a)**

The aforementioned offense was committed at the following location:

1400 Barton Creek BLVD  
Austin, TX, 78735

By the suspect Erika Wulff Jones at approximately 1806 hours on the 24<sup>th</sup> day of December, 2021.

My belief in the foregoing statement is based upon information provided to me by:

**PERSONAL OBSERVATION**

The Affiant, Deputy L. Luedecke #4861, is a licensed Peace Officer in the State of Texas, employed as a Deputy Sheriff by the Travis County Sheriff's Office

On 12-24-21 at 1806HRS I, Deputy L. Luedecke #4861 responded to 1400 Barton Creek BLVD, in reference to a Family Disturbance. TCSO dispatch advised a male called in saying a male vs. female disturbance was occurring and had been physical prior. Caller stated he was hit multiple times over the head. The caller gave the name of his wife Erica Lynn Jones. The call updated stating the female was holding a polished club in her hand and the caller stated she was trying to hit him with it. The call taker added that a verbal disturbance could be heard in the background.

Upon arrival, I spoke with the male identified as:

Jones, Alexander  
W/M [REDACTED]



Alexander stated his wife:

Wulff Jones, Erika  
W/F [REDACTED]

had hit him several times on the head. I could see his head was red and hair wet. He later stated Erika had hit him with both closed fists and open hands on his head in front of their child.

After further investigation, Erika was placed into custody in handcuffs inside the residence for assault with injury. While attempting to walk her to the patrol vehicle, she became rigid and refused to walk. She began screaming that she was not going to jail and had done nothing. I advised her multiple times to not resist and to walk. Myself, and Deputy J. Cavendish were able to get her out of the residence. I called for additional backup to assist as Erika kept trying to turn her body to go back towards the residence and refused to walk further towards the patrol vehicle. Additional patrol units arrived and Erika flailed causing her hand to come free from the handcuffs. She immediately began swing her fists and kicking at other deputies striking at least one.

The Affiant is a Commissioned Peace Officer in the State of Texas and is employed by the Travis County Sheriff's Office. The above described events occurred in Travis County, Texas. The Affiant also believes, based on the above stated facts, that the defendant has committed the offense of Resisting Arrest Misdemeanor A.
